

Weekly Report to PIAD

Brief Narrative *(August 19-23, 2019)*

For the period *August 19-23, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of three (3) entries: one (1) filed and one (1) in-progress under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php17,646,830.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
